**DIRECTIONS:** Address 16589 Edwards Shop Rd. Remington,  
VA 22734

**From North (Warrenton):** Take US 29S (James Madison Hwy) for about 16 miles and turn left on Rte. 674 (Elkwood, VA-Post Office on corner) Cross Railroad Tracks and bear left onto Kelly's Ford Rd. for about 5 miles. Do not turn left on Kelly's Ford Bridge (You will see signage). Stay straight on Edwards Shop Rd. Take first entrance to Equestrian Center on left about 1/3 mile down.

**From South: (Culpeper):** Take US 29N (James Madison Hwy) for about 10 miles and turn right on Kelly's Ford Rd. (Elkwood, VA & you'll see signage for Kelly's Ford). Go about 5 miles and road will become Edwards Shop Rd. as you pass Kelly's Ford Bridge (Stay Straight!). Take first entrance to Equestrian Center on left about 1/3 mile down.

**From East: (Fredericksburg on US 17)** From I-95 Take Us 17 North (Warrenton Rd.) for about 15 miles and turn left onto Summerduck Rd. for about 8 miles and turn left on Kelly's Ford Bridge (You will see signage). Turn Left on Edwards Shop Rd. after you cross Rappahannock River and take first entrance to Equestrian Center on left about 1/3 mile down.

**From East (Fredericksburg/Spotsylvania on Rte. 3)** At junction of I-95 and Rte. 3 head west toward Culpeper for approx. 19-19 miles to Rte. 620 (Shell gas station on corner). Turn right for about 2.5 miles to Rte. 610. Turn left for 1/2 mile to Rte. 620 (Edwards Shop Rd.). Turn right for about 5 miles and take 3<sup>rd</sup> right hand entrance to Equestrian Center (Not 1<sup>st</sup> entrance on right)!

### OUR JUDGE AND SEMINAR HOST...

Nicky Vogel currently resides in King George, Virginia, but is originally from the United Kingdom. She is a licensed U.S.E.F "R" dressage judge, a U.S.D.F silver medalist, as well as a U.S.D.F. certified 4<sup>th</sup> level instructor. She judges and instructs in an enthusiastic and positive manner, leaving the competitor and/or student craving for more valuable insight to improve his or herself and equine partner.

### OUR FORMAT...

At 8:30 am, in the heated indoor arena, Nicky Vogel will judge the 2011 U.S.D.F Introductory Test C as well as the 2011 U.S.E.F. Training Level Test 3 with two demonstration riders. At 1:00 pm Nicki Vogel will judge 2010 U.S.E.A. Novice Test A and 2010 U.S.E.A. Preliminary Test A as additional demonstrations. She will score and comment live on each movement as they are ridden over a P.A. system. Afterward, she will speak on the ideals of the "Judges' perspective" with a short question and answer session for the auditors. The Educational Seminar is *free* to everyone and is split into regular Dressage Tests & Eventing Tests, with also the Schooling Dressage Show Competition afterwards.



### SHOW RULES...

- Exhibitors ride at their own risk. Pursuant VA Code Annotated Title 3.2-6200-6203.
- The judge's decision is final.
- A.S.T.M./S.E.I. approved helmets with harnesses required for all riders and must be worn at all times while mounted on the show grounds.
- Current negative coggins required for each horse entry.
- Schooling is permitted in the outdoor sand arena.
- All dogs must be kept on leashes or left at home. No exceptions.
